## **NOTICE OF 29er WORLD COUNCIL MEETING 2016**

This is notice of the 29er World Council Meeting scheduled to be held in Medemblik, Netherlands at the World Championship on Monday, 25 July 2016, 1 hour after racing concludes for the day.

The proceedings of the World Council are governed by the 29er Constitution. The relevant paragraphs state:

“The Executive Secretary shall give such notice of (and only of) such resolutions as have been specified to him in writing 6 weeks before the meeting at which they are to be proposed” **The 6 week date to receive resolutions is June 13, 2016.**

Resolutions to the Council shall only be submitted by a National Class Association or a member of the Council. (This means a NCA that has paid its dues for the current year)

“The quorum at Council meetings shall be 40% of the member National Class Associations, represented in person or by proxy, who shall be from at least two continents and who are entitled to vote at the meetings. A member National Class Association may not vote more than two proxies.”

- We ask that each country be prepared with a short summary of 29er sailing in your country including memberships, # of participants at last Nationals and any other items you wish to share/discuss with other NCAs.
